Payment Information and Deadlines

Registration to participate in the North Idaho Conference as an exhibitor is a three-part process. **First**, you will complete the online application form. **Next**, your application will be reviewed by Homeschool Idaho and you will receive notice by email indicating whether your application was approved or declined. If approved, you will be provided with an invoice and payment instructions, the third and **final step** of the registration process. Homeschool Idaho reserves the right to refuse any application without further explanation.

Booth spaces are reserved only after the application is reviewed, approved, and payment in full is received.

PAYMENT

Once your application is approved, you will be emailed an invoice. Payment must be made within 10 business days after an invoice with payment instructions has been sent to the exhibitor by the Homeschool Idaho Exhibit Hall Coordinator. If you need additional time to arrange payment because your company's accounts payable process takes longer, please notify us at the time you receive your invoice. Your exhibitor registration is not complete until payment is received.

Idaho Temporary Seller Registration

All exhibitors must do the following:

- 1. Go to <u>tax.idaho.gov/GoToTAP</u> and under "Sellers and Promoters" click "Register as a Temporary Seller or Promoter."
- 2. Choose "Seller WITH Event ID" > "Next"
- 3. Choose "I am going to an event" > "Next"
- 4. Enter the Event ID: (The Event ID will be emailed to you prior to the event) > "Next"
- 5. Enter your Seller Information > "Next"
- 6. Choose Purpose: "I am not making taxable sales," "I have a regular permit" or "I need a temporary permit." > "Next"
- 7. Review your entry > "Submit"
- 8. Check your email account for further instructions or attached Temporary Sellers Permit (if applicable).

YES, all participants need to register but NO, existing Idaho Regular Sales & Use Tax holders do NOT need a Temporary Sellers Permit.

Exhibitor Guidelines

CONDITIONS OF PARTICIPATION

- Homeschool Idaho reserves the right to reject or refuse any exhibitor with or without comment.
- Only one regional sales representative will be allowed in the Exhibit Hall. The first such sales representative to complete an application and submit payment will be accepted. Individual book or product duplications are permitted. In the event of applications which involve duplicate product or service lines, Homeschool Idaho shall have the discretion to approve any or all such applications. Homeschool Idaho shall determine at its sole discretion what constitutes unacceptable duplication.
- Exhibitors may not share space with any other company or organization, or display materials for another company or organization without the consent of Homeschool Idaho.
- If the location or date of the conference changes, Homeschool Idaho will undertake to provide advance notice for exhibitors to withdraw or reschedule.
- Subject to these exhibitor guidelines, your application will only be deemed complete
 when it has been reviewed, an invitation is extended by Homeschool Idaho, and payment
 has been received.

CONFERENCE HOURS

• All booths must be manned for the entire time the Exhibit Hall is open. The Exhibit Hall will be open for business from 8:30 AM to 5:00 PM on Saturday, February 24th.

INSTALLATION/DISMANTLING

- Exhibitors will install exhibits between 7:00 AM and 8:30 AM on Saturday.
- No dismantling of exhibits or removal of product is allowed prior to 5:00 PM on Saturday.
 Exhibitors will remove exhibits before 8:00 PM on Saturday.

DAMAGES

 Each exhibitor is liable for any damage caused by such exhibitor to the building, the furnishings and equipment supplied to the exhibitor by Homeschool Idaho, or to the property of any other exhibitor.

COMPLIANCE

 Homeschool Idaho reserves the right to reject, eject, or prohibit any exhibit in whole or in part, or any exhibitor or its representatives, with or without cause. If an exhibit or exhibitor is ejected for violation of these guidelines or for any other stated reasons, no return of rental fees shall be made.

UNOCCUPIED SPACE

• If the exhibitor fails to occupy contracted space by the opening of the conference or otherwise fails to comply with these rules or the application, Homeschool Idaho shall have the right to use such space in any manner.

RULES OF DECORUM

- Exhibitors shall not criticize other exhibitors, speakers, attendees, the conference, or Homeschool Idaho, except to a Homeschool Idaho Board Member.
- Exhibitors will conduct themselves in a professional manner at all times and refrain from conduct or language which would discredit the conference, Homeschool Idaho, or home education.
- Exhibitor will not promote, endorse, nor encourage participation in a virtual charter school or other public school program.
- Exhibitors may not move their display outside the area of their booth space or stand in the aisle to hand out material. Exhibitors may place brochures, advertising or other promotional literature in their booth, but not in any other part of the conference facility.
- Custom display racks and counters may be used as long as they do not interfere with the visibility or operation of adjoining booths.
- No helium-filled, air-filled, or empty balloons allowed in the conference facility.
- Children under the age of twelve are only permitted to assist in a booth with prior permission from Homeschool Idaho. A responsible adult must accompany children at all times.
- Name tags must be worn for admittance to the conference and at all times while in your booth. You will be allowed two name tags for each booth. Additional booth attendants may be added for a fee.
- Exhibitors are responsible for collecting, reporting and paying sales tax on sales made at the conference.

REFUNDS

- Cancellations before 90 days of the event will receive a 50% refund of booth rental space monies paid.
- Cancellations before 60 days of the event will receive a 25% refund <u>if the vacated space is</u> resold.
- After 60 days, no refunds will be issued for any reason.
- All requests must be made in writing.

LIMITATIONS

- Homeschool Idaho or its representatives will not mediate any dispute between exhibitors.
- Distribution of printed materials, souvenirs, or other articles is restricted to the immediate space of the exhibit.
- Any part of the exhibit that is over 8 ft high must have prior written approval for installation by Homeschool Idaho.
- No individual public address system of any kind nor any music or audiovisual sound audible for more than 2' from the booth is permissible.
- Smoking, live or open flames and highly flammable material are not permitted on the property.

LIABILITY

• Homeschool Idaho assumes no responsibility for speaker/exhibitor inventory, materials, or equipment on the site of the conference. Speakers/exhibitors agree to hold Homeschool Idaho harmless from any and all liabilities from any cause; agree that Homeschool Idaho shall not be responsible for any loss, damage, or injury that may occur to the exhibitor, their volunteers, employees, or property from any cause whatsoever, prior, during or subsequent to the period covered by this contract. The speaker/exhibitor on signing the contract expressly releases Homeschool Idaho from and agrees to indemnify same against any and all claims for such loss, damage or injury.
